LADH0308 Finance Committee Policy

Under state law, each charter school is required to have a finance committee. The finance Committee has the following responsibilities:

- 1. The Finance Committee meets at least once per quarter.
- 2. The Finance Committee reviews and creates financial policies for the school.
- 3. All financial Policy changes will be recommended to the board for approval before they are valid.
